Council Member Parrish made a motion to grant signatory authority for Council Member Ansel Parrish, Council Member Loys Johnson, and Council Member Jeremy Hatcher, seconded by Council Member Brown. The vote was unanimous.

#### JOINT DEVELOPMENT AUTHORITY APPOINTMENT

Council Member Johnson made a motion to reappoint Nicole Hilliard to the Joint Development Authority of Mitchell County and Pelham for a four year term being 2016-2019, seconded by Council Member Parrish. The vote was unanimous.

## MAIN STREET MEMORANDUM OF UNDERSTANDING FOR 2016

Council Member Parker made a motion to authorize the Mayor to sign the Georgia Classic Main Street Program Memorandum of Understanding for the 2016 Program Year, seconded by Council Member Robinson. The vote was unanimous.

#### PELHAM HOUSING AUTHORITY UTILITY BASE RATES

Council Member Parrish made a motion to instruct the City Manager to bill all city customers equally for water, sewer, and gas base rates, seconded by Council Member Williamson. The vote in favor of the motion were Council Member Parrish, Council Member Williamson, Council Member Johnson, and Council Member Hatcher. The opposed votes were Council Member Brown, Council Member Parker, and Council Member Robinson. With the majority of votes in favor of the motion the motion will carry.

## PUBLIC ADDRESSES TO COUNCIL AMENDMENT

Council Member Parrish made a motion to amend the Public Addresses to Council Ordinance Section 1, Item B to include "unless they have previously appeared before Council at the City Council Work Session", seconded by Council Member Brown. The vote was unanimous.

Council Member Brown made a motion to accept and approve the audited financial reports submitted by Perry L. Henry LLC for the period of July 1, 2014 to June 30, 2015, seconded by Council Member Parrish. The vote was unanimous.
