With a quorum present, Mayor Eubanks called the meeting to order at 6:30 p.m. followed by the Pledge of Allegiance to the flag. Mayor Eubanks provided the opening prayer.

REGULAR SESSION – LED BY MAYOR EUBANKS

APPROVAL OF REGULAR MEETING AGENDA

Council Member Adams made a motion to approve the agenda as presented, seconded by Council Member Hatcher. The vote was unanimous.

CITIZEN COMMENTS

Dr. Anjel Gibson gave a special thanks to the City of Pelham, Mayor, and Council for obtaining the Community Block Grant Program for Housing.

Stephen Brown spoke about the ditch on Wilson Street needing to be repaired.

RED RIBBON WEEK PROCLAMATION

Mayor Eubanks read the Red Ribbon Proclamation proclaiming October 23rd- 31st, 2019 as Red Ribbon Week in Pelham, Georgia. The Drug Free Rally will be held at the Pelham High School gym on October 22nd at 5:30 p.m. with National Night Out to follow.

Council Member Williamson made a motion to adopt the Red Ribbon Proclamation, seconded by Mayor Pro-Tem Brown. The vote was unanimous.

COUNCIL MINUTES

Council Member Adams made a motion to approve minutes from the September 19, 2019 Regular Council Meeting, September 26, 2019 1st Public Hearing, September 26, 2019 2nd Public Hearing, September 26, 2019 Called Meeting, October 3, 2019 3rd Public Hearing, and October 3, 2019 Called Meeting as presented, seconded by Mayor Pro-Tem Brown. The vote was unanimous.

QUARTERLY REPORTS

Mitchell County Development Authority provided a report for the council's review.

Pelham Chamber of Commerce not report.

Pelham Downtown Development Authority/Main Street provided a report for the council's review.

REZONING APPLICATION

The purpose of the rezoning application is to consider rezoning specific properties in the Northwest and Northcentral part of town. The proposal is to rezone sections of northwest and northcentral Pelham from R1 to R2 to accommodate manufactured homes. The City Planning Commission held a public hearing on September 5th, 2019. Following the hearing, they voted unanimously to recommend the Council pass this application as presented.

Council Member Parrish made a motion to adopt the City's R2 Rezoning Application, **seconded by Mayor Pro-Tem Brown. The vote was unanimous.**

CORNERSTONE CONTRACT

Cornerstone Engineering Consultants, Inc. provided a proposal for the concrete inspection for the Freedom Park project. GDOT requires a concrete inspector to test and inspect the work done by AC Blount Concrete. Their estimated fee is \$6,500.

Council Member Williamson made a motion to adopt the Cornerstone Contract, seconded by Council Member Parrish. The vote was unanimous.

MUNICODE CONTRACT

Municode provides Ordinance Codification and the last published codified City Ordinances was 2003. The project will include codification of the City ordinances, publication of 5 hard copies, and publication of the ordinance on the world wide web. The estimated cost is \$12,750 to bring the codification up to date, and the annual subscription is \$645.

Council Member Adams made a motion to adopt the Municode Contract, seconded by Council Member Williamson. The vote was unanimous.

BEALL TIRE AGREEMENT

The Beall Tire Agreement is to provide a proposal to the Council to clear up ownership of Beall Tire's lift station. The ordinance states installation and maintenance are the responsibility to the owner. The pump physically resides on Beall Tire's property. To clear up ownership, the agreement proposes the City pays the cost of repairs, and in turn, Beall Tire assumes total ownership responsibilities for the pump.

Council Member Parrish made a motion to adopt the Beall Tire Agreement, **seconded by Council Member Adams.** The vote was unanimous.
