REGULAR SESSION – LED BY MAYOR EUBANKS

COUNCIL MINUTES

Council Member Adams made a motion to approve minutes from the March 17, 2020 Regular Council Meeting, and Called Meeting of March 24, 2020, as presented, seconded by Mayor Pro-Tem Brown. The vote was a roll call vote and it was unanimous.

179 MATHEWSON STREET

A Resolution to deed the property at 179 Mathewson over to the DDA.

A Resolution of the Mayor and Council of the City of Pelham, Georgia authorizing the conveyance by quit claim deed of all the City of Pelham's interest in certain property to the City of Pelham Downtown Development Authority; repealing all resolution in conflict herewith; and for such other purposes.

Council Member Hodges made a motion to approve the Resolution to quit claim the property to the DDA, seconded by Mayor Pro-Tem Brown. The vote was a roll call vote and it was unanimous.

BUTLER STREET

Semi-Trucks on Hwy 93 traveling East turnoff on to Butler Street running over infrastructure which lead to a water main with a shallow valve. The solution would be to designate Butler Street as a no thru truck street.

Council Member Hodges made a motion to designate Butler Street as a no thru street to semi's, seconded by Council Member Parrish. The vote was a roll call vote and it was unanimous.

TSPLOST PROJECT LIST

Council Member Williamson made a motion to move forward with the TSPLOST presentation, seconded by Council Member Parrish. The vote was a roll call vote and it was unanimous.

EMPLOYEE BENEFITS

The City offers its employees health, dental, vision, short-term disability, long-term disability, an accident and death life insurance and the option for employees to purchase a larger life insurance. The renewal for the health dental, and vision is to be in place by May 1st. It is recommended that the City proceed with the Partially Self-Insured Plan from Diversifies Benefits Administrator.

Council Member Williamson made a motion to adopt the Employee Health Benefit Plan proposed by Diversifies Benefits, seconded by Mayor Pro-Tem Brown. The vote was a roll call vote and it was unanimous.
