With a quorum present, Mayor Eubanks called the meeting to order at 6:33 p.m. followed by the Pledge of Allegiance to the flag. Mayor Eubanks provided the opening prayer.

REGULAR SESSION - LED BY MAYOR EUBANKS

APPROVAL OF REGULAR MEETING AGENDA

Council Member Adams made a motion to approve the agenda as presented, seconded by Council Member Hodges. The vote was unanimous.

COUNCIL MINUTES

Council Member Hodges made a motion to approve minutes from November 19, 2020 Council Meeting, as distributed, seconded by Mayor Pro-Tem Brown. The vote was unanimous.

POLICE DEPARTMENT ANNUAL AWARDS

Mayor Eubanks presented the Police Department Annual Awards to the following:

Reggie Feagin received the Officer of the Year Award.

Helen Cody received the Employee of the Year Award.

HB 879 IMPLEMENTATION

State Legislators in the last session passed HB 879, and Governor Kemp signed it on August 3rd. The HB addresses 5 key issues:

- 1. centralized permitting
- 2. Sunday sales
- 3. home delivery of alcohol
- 4. local control of distancing
- 5. regulates tasting events

The consensus of the city council was to have City Attorney Coleman to draw up an amendment for the City Council to consider regarding the home delivery of alcohol.

City Attorney Coleman made a recommendation to draw up a model ordinance and have it placed on the agenda for a vote during the January 2021 meeting.

No votes were taken on this agenda item during the December 2020 council meeting.

ANNUAL CALENDAR

The holiday calendar in accordance with the City Personnel Policies and Procedures. Christmas is an observed holiday, and it falls on Saturday in 2021. A Saturday holiday would normally be observed on the Friday prior. In this case Friday, December 24th is also an observed holiday. The calendar observes Christmas on Monday, December 27th. (See attachment 1).

The Council meeting calendar maintains the standard 2nd and 3rd Thursday of each month with one exception. November 11th is Veterans Day, an observed holiday. November's workshop has been placed on the 1st Thursday of the month. (See attachment 2).

Council Member Hodges made a motion to approve the Holiday calendar, Council calendar, and the calendar for the various Authorities, Boards, and Commissions as presented, seconded by Council Member Parrish. The vote was unanimous.

ANNUAL APPOINTMENTS

The list of appointed officials and assignments of elected officials of other governmental bodies was presented. (See attachment 1).

The list of City Authorities, Boards, and Commissions was presented as information purposes only. (See attachment 2).

Council Member Adams made a motion to replace Councilman Williamson with Council Member Hodges as the City Council Liaison to the Pelham Chamber of Commerce Board, add Council Member Hodges to the City's checking accounts at Pelham Bank, and reappoint all other officials as presented in attachment 2 to the December 2020 minutes, seconded by Mayor Pro-Tem Brown. The vote was unanimous.

ANNUAL CONTRACTS

The list of Annual Contracts and Agreements were provided to the Council for review. They are four contracts, which require a reapproval or extension, Prime Ground Maintenance for yard debris removal, American Tank Maintenance for the continue maintenance program on the City's water tanks, Edmunds & Associates for financial software, and extend the lease with Thomasville Community Resource Center.

Council Member Hodges made a motion to extend for another year, January through December 2021, under the current terms, the City's contract and service agreements with Prime Ground Maintenance, American Tank Maintenance, and Edmunds and Associates for respective services per current contracts, and extend the current lease with Thomasville Community Resource Center for the rental of the Pelham Senior Center and Donnie Cochran Community Center until May 2021 as presented, seconded by Council Member Adams. The vote was unanimous.

Reviewed department reports from November 2020 from the Pelham Police Department, Fire Department, Utility Department, and Code Enforcement.
