With a quorum present, Mayor Eubanks called the meeting to order at 6:35 p.m. followed by the Pledge of Allegiance to the flag. Mayor Eubanks provided the opening prayer.

SWEAR IN TO OFFICE FREDRICK DAVIS

City Clerk/Election Superintendent Lisa Austin administered the Oath of Office to new Council Member Fredrick Davis.

REGULAR SESSION – LED BY MAYOR EUBANKS

APPROVAL OF REGULAR MEETING AGENDA

Council Member Hodges made a motion to approve the agenda as presented, seconded by Council Member Robinson. The vote was unanimous.

COUNCIL MINUTES

Mayor Pro-Tem Brown made a motion to approve minutes from August 20, 2020 as distributed, seconded by Council Member Williamson. The vote was unanimous.

CARES ACT BUDGET AMENDMENT

The State has the authority to potentially allocate \$1.23b of their CARES Act fund to local governments. Pelham's initial allocation is \$181,436.08. Pelham has received 30% of the 30% that has been distributed to local governments. The remaining 70% of 30%, is \$127,005.96 of revenue which has also been received. The recommended budget amendment for the revenue of \$127,005.96 is restoring the following budget shortfalls:

- Christmas Bonus \$25,561.29
- Fireman \$27,551.36
- Road Repair \$25,000
- House Demolition \$7,200
- Education, Conference, Travel \$10,000
- Balance \$31,693.31

Council Member Adams made a motion to recommend the budget amendment presented to the City Council by the City Manager at work session includes reinstating Christmas Bonuses, Fireman position, Road Repair, House Demolition, Education, Conference, Travel, and keeping the balance of \$31,693.31 as a contingence to be approved as presented seconded by Mayor Pro-Tem Brown. The vote was unanimous.

PROPERTY/LIABILITY INSURANCE RENEWAL

The City received two quotes from GIRMA and Dover-Rock Insurers for the Annual Personal & Liability Insurance Renewal. The current central policy is with the carrier HCC Public Risk, Georgia, affiliated with Tokio Marine HCC-Public Risk Group. The HCC coverage is the same coverage, with one exception. The deductible on equipment has gone from \$1,000 per claim to \$5,000 per claim to match the deductible on buildings. Dover-Rock premium has been proposed for the policies at \$124,531 annually. This premium is only a 6.6 increase over last year's premium. Dover-Rock ancillary policy is Cyber, and the annual premium is \$2,454 for a total of all policies of \$126,985. GIRMA ancillary policy is with Cyber and the total of all policies is \$124,691. GIRMA policy includes additional coverages and exceed coverage for comparable polices, but Dover-Rock policies do have a couple of coverages that exceeds GIRMA.

Council Member Hodges made a motion to award the Property/Liability Insurance renewal to Dover-Rock **second by Council Member Parrish. The vote was unanimous.**

2021 CDBG WAY FORWARD

In order to move forward with the 2021 CDBG applications are due at the end of March 2021. In order to do an application a procurement for a grant administer and possibly an engineer needs to occur well in advance of the application deadline. The CDBG 21 application timeline, and the history of past CDBG projects were provided. The following needs were outlined:

- Housing
- Storm Water Drainage (ditch improvements)
 - From West R.R. St. south of the fire station in a southern direction to city limits
 - o From Hollingsworth St. to US 19 an easterly ditch/creek
 - o Both run through a flood area in Pelham
- City-wide sewer rehabilitation
 - Continuous of the long running rehabilitation of very aged sewer system throughout the City
- Asbestos water line on Cotton Ave.
 - Replacement of an identified carcinogenetic material in a vital infrastructure connecting the Cotton well with the north water tower.

Mayor Pro-Tem Brown made a motion for the coming year CDBG 21 be for housing, seconded by Council Member Robinson. The vote was unanimous.

Reviewed financial reports of August were presented.
