## PELHAM DOWNTOWN DEVELOPMENT AUTHORITY AND MAINTSTREET

Christian Drake Downtown Development Authority and Mainstreet Director reported on the following:

#### DDA

- Created a directory for our vacant building's downtown
- Acquired the building at 171 Mathewson Avenue with the help from the Mitchell County Development Authority. (The roof will be repaired next week)
- City gifted the Roses building to the Pelham Development Authority (The roof will be fixed within the next week)
- Website Redesign Completed
- Planning on having a stakeholder meeting to gauge what citizens want out of the DDA.
   That information will then be used to create the strategic plan for the city.

#### **Main Street**

- Back to school event was held and 310 bundles were given out to children and 26 people completed their census during that event.
- Mainstreet held a virtual concert and, raised \$525 dollars.
- During the back to school event and census events that have been held they were almost 100 volunteer hours put in from citizens.

## **ALCOHOL APPLICATION BACKSTREET SEAFOOD**

Backstreet Seafood is a new licensed business in Pelham. Mr. Jesse Romero bought the former Captain's Dons. They are in the process of renovating the business and will open soon. Mr. Romero is applying for a retail malt beverage and wine consumption license.

Council Member Robinson made a motion to approve the alcohol license for Backstreet Seafood for Mr. Jesse Romero, seconded by Council Member Parrish. The vote was unanimous.

## **ALCOHOL APPLICATION DISCOUNT LIQUOR**

Discount Liquor is being bought by Prestige Worldwide Liquor, LLC on Baggs Ave at US 19. Mr. Jesse Young is purchasing it from the previous owner. Mr. Young is applying for a retail malt beverage, wine and distilled spirits package licenses.

**Council Member Robinson made a motion** to approve the alcohol license for Discount Liquor for Mr. Jesse Young, **seconded by Mayor Pro-Tem Brown. The vote was unanimous.** 

## **ALCOHOL LICENSE RENEWAL 2021**

The 2021 Alcohol License list was presented for approval of various business establishments in which sell alcohol. The 2020 business license expire on December 31, 2020.

#### City's Public Notice on Halloween

#### **PUBLIC SERVICE ANNOUNCEMENT-HALLOWEEN**

The Centers for Disease Control and Prevention (CDC) guidelines on Halloween have identified traditional door-to-door trick-or-treating and other activities as high-risk activities and recommends avoiding these types of activities. The City of Pelham's Mayor and City Council concurs with the CDC and encourages everyone to adhere to the guidelines this Halloween season.

The guidelines identify other high-risk activities, which should also be avoided, such as:

- Trunk-or-treat events with treats handed out to large groups from trunks of cars,
- Indoor costume parties,
- Indoor haunted houses,
- Hayrides/tractor rides with people who are not in your household,
- Going to fall festivals outside your community

To this end, the City will not be setting hours for trick-or-treating this year.

#### Way forward addressing violence in Pelham

- Going forward, recommend the Council lean on the staff to deliberate and coordinate solutions. The staff through the City Manager require elected official to keep us informed of what they are hearing from the community.
- To further collect information and interact with the community on the issue, the Police Chief is coordinating an outreach event at the Bonita Cochran neighborhood on October 29<sup>th</sup>.
