COUNCIL MEETING MINUTES

COUNCIL BOARD APPOINTMENTS

REAPPORTIONMENT ORDINANCE

Council Member Robinson made a motion to table approving the reapportionment until the next meeting, **seconded by Mayor Pro-Tem Brown. The vote was unanimous.**

DEPARTMENT REPORTS

Council reviewed department reports from December 2021 from the Pelham Police Department, Fire Department, Utility Department, and Code Enforcement.
