FY23 BUDGET AMENDMENTS

City Manager Drake is recommending the Council approve the budget amendments for the department increases of \$10,000 for the Mayor and Council departments for training opportunities, \$15,000 for the Police Department for pay raises, \$50,000 for the Fire Department for pay raises, and \$199,987 for the Police Department for the purchase of radios.

SOLID WASTE INCREASE

City Manager Drake is recommending the Council approve the increase of the sanitation rates to account for Waste Management's 5.4% CPI adjustment.

ZONING BOARD OF APPEALS

City Manager Drake discussed efforts to fill the new Pelham Zoning Board of Appeals.

DONNIE COCHRAN COMMUNITY CENTER

Council Member Brown discussed options to renovate the Donnie Cochran Community Center including using an inmate detail to complete the work.

CHIP

City Manager Drake presented information to the Council to begin the discussion of the City becoming a CHIP (Community Home Investment Program) community and how it will help the City address housing needs in the community.
