EMERGENCY MANAGEMENT AND EMERGENCY SERVICES ORDINANCE

PICKLEBALL COURTS

DDA/Main Street Director addressed the council to recommend the installation of two pickleball courts at Frances Davis Park. This project will utilize one of the pre-existing concrete pads currently used for basketball. The total cost of the project is \$34,300.00, and it will involve resurfacing the concrete pad to meet pickleball court standards. After evaluating multiple vendors, I recommend awarding the project to Premier Surface Solutions from Tallahassee, Florida Premier Surface Solutions provided the most competitive pricing compared to other vendors, including FlexCourt, Lewis Concrete, and Innovative Sport Surfacing.
