#### DEPARTMENT REPORTS

#### RESOLUTION ESTABLISHING END OF YEAR SALARY SUPPLEMENT

City Manager Drake presented a resolution 12-12-24-01 for Councils approval. The purpose of this resolution is to award City of Pelham employees a salary supplement that has been employed for at least one year. The supplement will be given in the following time of service tiers and amounts:

Years of Service	Amount
1-4 years	\$350.00
5-9 years	\$400.00
10-14 years	\$450.00
15-19 years	\$500.00
20-24 years	\$550.00
25-29 years	\$600.00
30+ years	\$600.00 (cap)

Council Member Adams made a motion to approve resolution 12-12-24-01 to give City of Pelham employees an end of year supplement at the years of service and amounts presented, seconded by Council Member Davis.

After discussion, Council Member Adams amended his motion to include a year of service and amount cap of 30 years at \$650.00, seconded by Council Member Davis. The vote was unanimous.

## **ELECTION ORDINANCE**
