REGULAR SESSION – LED BY MAYOR EUBANKS

APPROVAL OF REGULAR MEETING AGENDA

Council Member Robinson made a motion to approve the agenda as presented, **seconded by Council Member Johnson. The vote was unanimous.**

MINUTES FROM PRIOR MEETING

Council Member Parrish made a motion to approve minutes from the August 9, 2018 Called Meeting, and August 16, 2018 Regular Meeting as presented, **seconded by Council Member Hatcher**. The vote was unanimous.

CITY CODE ETHICS

Council Member Johnson made a motion to approve an Ordinance to amend City Code of Ethics to provide for penalties for violations to repeal conflicting ordinances, seconded by Council Member Williamson. The vote was unanimous.

CHAMBER OF COMMERCE CONTRACT

Council Member Williamson made a motion to approve the contract for services with the Pelham Chamber of Commerce, seconded by Council Member Parrish. The vote was four yea votes by Council Member Williamson, Council Member Parrish, Council Member Robinson, and Council Member Johnson. One abstained vote by Council Member Hatcher. Mayor Eubanks stated the motion will carry.

AMENDMENT TO ALCOHOL BEVERAGE ORDINANCE

Council Member Johnson made a motion to approve an amendment to the Alcohol Beverage Ordinance that will allow one day event Alcohol Consumption Permits to be issued by the City and dispense with the second reading, seconded by Council Member Robinson. The vote was unanimous.

LMIG RESURFACING BIDS AND AWARD

Council Member Parrish made a motion to approve LMIG Resurfacing Bids and award bid to The Scruggs Company with a low bid of \$110,418.82 to resurface Proctor and Wilder Streets, seconded by Council Member Johnson. The vote was unanimous.

REPAIR FENCES AT FRANCIS DAVIS AND COLLINGSWORTH PARK

Council Member Hatcher made a motion to replace the fence at Collingsworth Park and repair the fence at Francis Davis Park, **seconded by Council Member Parrish. The vote was** unanimous.

SURPLUS BERETTA GUN

Council Member Johnson made a motion to declare a Beretta gun model 92FS serial number #BER383705Z as surplus and authorize the sale of same to Mrs. Helen Cody, **seconded by Council Member Hatcher.** The vote was unanimous.

ADJOURN


